Kenya Shilling: The Kenya shilling was unchanged on Thursday but was under pressure against the dollar as few inflows did not match high dollar demand from oil and energy sectors.

Money-Market: The overnight rate rose to 4.6163% on a volume of Kes.16,170B compared to Kes26.090B posted in the previous session.

Global Trends:

EUR: The euro strengthened against dollar on Thursday after European Central Bank adopted more hawkish stances than markets had expected, giving a boost to the euro.

GBP: The pound appreciated against the dollar on Thursday after the Bank of England surprised investors by raising interest rates, while the European Central Bank announced a cut in monetary stimulus.

JPY: The Japanese yen gained against the dollar on Thursday as markets moved toward risk while sorting a raft of central bank policy statements for clues to coming differences in interest rates.

GOLD: Gold rose more than 1% on Thursday as the dollar weakened after the U.S. Federal Reserve decided to accelerate the withdrawal of its pandemic-era stimulus in a widely expected move.

OIL: Oil prices rose around 2% on Thursday, as record U.S. implied demand, falling crude stockpiles and an upbeat economic outlook from the Federal Reserve trumped fears of the Omicron coronavirus variant hurting global consumption.

USD: The U.S. dollar steadied on Thursday but was headed toward a second day of losses as markets sorted a raft of central bank policy statements for clues to coming differences in interest rates and support for their economies.

U.S. producer prices increased more than expected in November as supply constraints persisted, leading to the biggest annual gain since the series was revamped 11 years ago.
